Dear Mr. Pevzner,

I hereby confirm receipt of your two letters from January 24, 1975 and February 29 1975, which we have read with great interest.

Since you have not yet received confirmation from the International Federation for Human Rights in Paris about the conference that was to have been held in the middle of this month, I presume the conference was not held and therefore the question of funding for the purpose of travel to this conference is no longer relevant.

As for the issue of the annual allowance we normally provide for your association, I have asked for such allowance for the 1975/76 fiscal year for 2,000 Israeli Pounds. Once I know what has come of this request I shall promptly inform you.

With respect to your question regarding the funds we allocated to you for the purpose of travel to conferences held by the international federation in Paris, and as annual grants for your activity in the country, I hereby attach a copy of my letter on this matter from June 11, 1973, in which I added, in handwriting, the details of the allocations we have received for you since that letter was written. I hope these details will solve the problems that have arisen in your accounting.

Dear Mr. Pevzner,

I hereby confirm, with thanks, receipt of your letter from May 22, 1973.

For the sake of order, I hereby provide a summary of the various grants we have allocated for your association over the past two years, as reflected in our files.

Given this situation, we now ask for a 1750-pound allocation for a grant for the 1973/74 fiscal year.

As for the question that appears at the end of your letter, we do not think there is a point in us asking to bring up the issue of the genocide in Burundi at the Paris conference. We must focus on problems of this sort that directly relate to us, such as the problem of Jews in Arab countries.
